The club usually awards £1,000 each year to Lakeside's nominated charity. In view of our restricted use of their facilities, the proposal is to award a total of £1,000 as follows: £500 to Lakeside nominated charity.

£250 to Stop Domestic Abuse (see notes below for more details on this charity). £250 to Portsmouth Hospitals Charity (see notes below for more details).

Stop Domestic Abuse: the reason this is important at this time is the impact Covid-19 lockdowns has had on domestic abuse. Domestic abuse is often a hidden crime however ONS data has seen an increase in domestic abuse related crime and an increase in use of domestic abuse helplines during Covid-19. To support this type of charity at this time feels like a good thing to do.

Portsmouth Hospitals Charity is registered UK Charity which supports the work of Portsmouth Hospitals University NHS Trust to help enhance patient care. It funds a range of projects including improvement to existing facilities, the purchase of new

and state-of-the-art equipment, staff training, and helps foster research and innovation. This would not be possible without kind donations from the local community, legacies, corporate donations and grants including money from NHS Charities Together.

Portsmouth Hospitals Charity also has a Working Together Fund which supports projects across the entire Trust. From this fund we have supported the Trust with a new garden space, new robot, WIFI across the Hospital and much more.

There are also 60 individual funds designated for a range of departments across the Trust. This also includes our Thank You Fund which started in March 2020 and has been specifically for supporting staff during the current crisis and beyond. From this we have funded psychological support, refreshments, water coolers, picnic benches and much more.

b) Will the committee please consider moving the club back to the Mountbatten Centre." Proposed by Denis Broadway.

"I believe this would raise the profile of the Portsmouth Joggers Club by being in a sports centre that is in town and not on the outskirts in an office block.
